It can be difficult to develop these habits in later years, as students become more heavily involved in social life, recreational activities, and part-time employment.

Policy Statement

In partnership with families, Loreto College is entrusted with the care of young people and works together with families for the wellbeing of all students.

Loreto College believes all students are capable of learning. Students learn at different rates and through a variety of experiences, in a wide range of settings. We acknowledge that effective learning, and telearner's self-esteem, are closely linked, therefore learning should be intrinsically rewarding and feedback should be provided regularly.

Home Study Policy



Principles

This policy is available on the College website.

- Students benefit from completing home study regularly. Home study helps them develop organisational and time-management skills, self-discipline, skills in using out-of-school resources and personal responsibility for learning.
- Students should use their school planner to assist in recording set home study and due dates for assessment. Students are taught in Year 7 how to use their planner most effectively.
- Students must use their college Learning Management System SIMON, email, and College
 platforms. Parents can monitor completion of homework through PAM, this method provide a
 means of regular communication between parents and the school.
- Failure by students to complete home study on a regular basis will be followed up with parents.
- Middle Years 7 9 Home study is not an extra task; it enables the extension of class work by
 practising skills or gathering extra information or materials. Includes daily independent reading,
 revision and extension of class work, projects and assignments, essays, and research.

Procedural guidelines for families

How much time should be devoted to home study?

As a general guide:

- Year 7 a minimum of one hour per night 5 hours per week
- Year 8 a minimum of one and a half hours per night 7-8 hours per week
- Year 9 a minimum of two hours per night 10 hours per week
- Year 10 a minimum of two and a half hours per night 12-13 hours per week
- Year 11 a minimum of three hours per night 15 hours per week
- Year 12 a minimum of three and a half hours per night at least 17-18 hours a week
